1. Preamble

The Ministry of Micro, Small & Medium Enterprises (MSME), Government of India, has launched the "A Scheme for Promotion of Innovation, Rural Industry & Entrepreneurship (ASPIRE)" initiative. This scheme is designed to establish a network of technology centres and incubation centres to accelerate entrepreneurship, with a particular focus on promoting startups in the agro-industry sector. The primary aim of the ASPIRE scheme is to foster entrepreneurship and encourage innovation in the agro-industry.

The Indian Institute of Entrepreneurship (IIE), Guwahati, serves as the Nodal Agency for the development of clusters under this scheme. IIE is responsible for program fund management, as well as the monitoring and evaluation of project implementation.

J.K.K. Munirajah College of Agricultural Science LBI has been designated as the Implementing Agency (IA) for this project. As part of their responsibilities, the IA must adhere to the General Financial Rules (GFR) and other relevant documents of the Government of India, ensuring compliance with tender procedures for the procurement of machines, equipment, and accessories.

The IA has issued a tender invitation for manufacturers and authorized distributors with a minimum of three years of experience in supplying agro and food-based industries. The tender is for the supply, erection, and commissioning of machinery, equipment, and accessories necessary for the establishment of a Livelihood Business Incubator (LBI) in Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu. **The tender notification specifies that the date of opening of tenders is set for 23rd September 24 at 1:00 PM.**

2. Scope of Work

- The successful tenderer should undertake supply, erection and commissioning of machineries, equipment's and its accessories within the common facility center of J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI, on turnkey basis.
- The detailed specification and list of equipment is given in Annexure-I.
- The successful tenderer should adhere the schedule of supply as prescribed in the schedule of supply.

The location of contract execution is at Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu State. The successful tenderer should undertake supply, erection, commissioning, demonstration, trial production using the supplied machines and product testing from NABL accredited lab.

4. Language of the Tender

The Tender prepared by the tenderer as well as all correspondences and documents relating to the tender shall be in English language only. If the supporting documents are in a language other than English, the notarized translated English version of the documents should also be enclosed.

6. Pre-Bid Meeting

The tenderers shall send their queries in writing if any to reach IA within 7 days of publication of tender. If multiple number of queries are received by the IA, a pre bid meeting will be scheduled and details uploaded on the website. Otherwise, the IA and TA will resolve, send answers to queries on email. The tenderers are advised to check <https://jkkmcas.org/index.php/tender.html> for up-to-date information like date of pre-bid meeting etc. Non attending of pre-bid meeting is not a disqualification. 7. Amendment of the Tender Document

To issue Amendment; IA in consultation with NA/TA as a result of a query, suggestion or comment of an Applicant or a Respondent, may modify the tender document by issuing an addendum or a corrigendum at any time before the opening of the tender, with the concurrence of the tender/working committee. Any such addendum or corrigendum will be uploaded on <https://jkkmcas.org/index.php/tender.html> and the same will be binding on all Applicants or Respondents or Tenderers, as the case may be.

8. Authorization of the Tender

The Tender should be signed on each page by the tenderer or by the person who is duly authorized for the same by the tenderer.

9. Submission of Tender in Two Cover System

- a) The tender comprises of a single package and the tender shall be in whole for all the equipment listed in this document.
- b) Tenders should be submitted in two parts separately:
 - a. Part I will cover TECHNICAL BID
 - b. Part II will cover FINANCIAL BID
- c) Tenderers should ensure submission of all documents pertaining to Part-I and Part II proposals separately as per the Check list given in Annexure -IX
- d) Tenderers are requested to place Part I and Part II documents in separate sealed covers.
 - a. Part I cover to be superscripted as “Part I – Technical bid”
 - b. Part II cover to be superscripted as “Part II – Financial bid”respectively, mentioning the name and address of the Tenderer in each of the covers.
- e) These two sealed covers (Part I and Part II) must be placed in a single outer cover superscripted as “Tender for the supply, erection and commissioning of machineries, equipment and its accessories for the Livelihood Business Incubator and addressed to “J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI” mentioning the name and address of the Tenderer in the outer cover. Tenders shall be submitted in sealed cover and unsealed tenders would summarily be rejected.
- f) Tenders should be dropped only in the tender box kept at the office of “J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI, Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu State”. Tenders will not be received by hand.
- g) Tender fees & EMDs shall be enclosed with Part 1 i.e., technical bid folder.
- h) A tender once submitted shall not be permitted to be altered or amended.
- i) **Alternatively, the tenders can be submitted through registered post so as to reach the above address on or before 12:00 PM on 23/09/2024. Tenders received after the specified time will not be considered and IA will not be liable or responsible for any postal delays.**

10. Earnest Money Deposit

The Tender should be accompanied by an Earnest Money Deposit (EMD) in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee drawn on any banking branch payable in favour of IA Account "J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI" payable at Gobichettipalayam, Tamil Nadu State.

- The EMD in any other form will not be accepted. The Earnest Money Deposit will be returned to the unsuccessful tenderers at the earliest on the expiry of final bid validity and latest on or before the 30th day of the award of contract. The bids received without EMD will be summarily rejected.
- The Earnest Money Deposit will be retained in the case of successful tenderer and it will not earn any interest and will be dealt with, as provided in the terms and conditions of the tender.
- If the tenderer emerges as the successful bidder and after subsequent issuance of letter of acceptance by the IA, failure to sign the agreement, to remit the Security Deposit or to execute the contract as per tender conditions, will result in the forfeiture of the EMD.
- EMD clause shall be governed as per Rule 170(i) of General Financial Rules (GFR) 2017.

11. Validity

- The rate quoted in the Tender should be valid for the acceptance by the IA for a minimum period of 365 days from the date of opening of the Tender.
- The accepted rate of the successful tenderer is valid till the entire contract is fully completed. Escalation in the rates will not be entertained under any circumstances.

12. Opening & Evaluation of Tender

The tender box will be closed on 23/09/24 @ 12:00 pm and the received tenders in the tender box will only be opened. Tenders received after specified date and time will not be accepted. The **Tender will be opened by the Tender committee at 23/09/24 @ 1:00pm** in the presence of the available Tenderers/ representatives of the Tenderers who choose to be present.

The venue of the Bid opening shall be at: "J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI, Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu State". The Tenderers or their authorized agents are allowed to be present at the time of opening of the tenders.

Tender Committee will inform the attested and unattested corrections before the Tenderers and sign all such corrections in the presence of the Tenderers. If any of the Tenderers or agents are not present then, in such cases the Committee will open the tender of the absentee Tenderer and take out the unattested corrections and communicate it to them. The absentee Tenderer should accept the corrections without any question whatsoever.

If the date fixed for opening of the tender happens to be a government holiday, the sealed tenders will be opened at 11.00 AM on the next day.

The Technical bid will be evaluated by the tender committee in terms of the qualification Criteria. The committee reserves the right to disqualify any of the tender in case the Committee is not satisfied with the documents furnished.

After the completion of evaluation of technical bids, the tenderers declared as qualified by the Committee, will be informed the date of opening of financial bid (Part II).

13. Price Offer

- a) The Financial bid should be kept only in the Part II cover.
- b) The Financial bid should be prepared as per Annexure-VIII.
- c) The price should be neatly and legibly written both in figures and words.
- d) In case of discrepancy between the prices quoted in words and figures lower of the two shall be considered.
- e) If a bidder quotes NIL charges/consideration, the bid shall be treated as unresponsive and will not be considered.
- f) Part-II (Financial Bid) should not contain any commercial conditions. Variation in the commercial terms and conditions of the tender will not be accepted.

14. Evaluation of the Price

- a) The Tender committee will examine for complete, properly signed and error-free nature of the Financial Bid (Part II).
- b) The comparison of the rates offered shall be based on the total all-inclusive rates offered

15. Award of Contract

- a) The Tenderer who has quoted lowest price (L1) will be issued the 'Letter of Acceptance' by the Implementing Agency.
- b) In unavoidable circumstances, such as receipt of very limited bids or the proposal prices are substantially higher than the market value / updated cost estimate or available budget, the committee may decide upon resorting to Negotiation with the lowest evaluated responsive bidder. In such cases, the Tenderer who has quoted lowest price (L1) will be invited for negotiations and after finalizing the negotiated rate, Letter of Acceptance will be issued.

16. Security Deposit

- a) On receipt of the Letter of Acceptance from IA, the successful tenderer should remit a Security Deposit (SD) of 3% of the value of the contract in the form of Account payee Demand Draft from any Specialized Institutional Banking Branch or irrevocable Bank Guarantee with a validity period of one year in favour of "J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI", before any claim for payment is entertained by the Tendering authority.
- b) The tenderer may also request the Tender Committee to deduct the 3% SD payable to "J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI", from the first payment due to the tenderer.
- c) Any other amount pending with IA will not be adjusted under any circumstances, against the Security Deposit if so requested.
 - a. If the Security Deposit amount is not paid within the time specified, the EMD remitted by the tenderer shall be forfeited, besides cancelling the communication of acceptance of the Tender.
- d) Security Deposit amount remitted will not earn any interest

17. Agreement

The successful tenderer should execute an agreement as may be drawn up to suit the conditions on a non-judicial stamp paper of value, within 10 days of declaration of result of tender and shall pay for all stamps and legal expenses incidental thereto. In the event of failure to execute the agreement, within the time prescribed, the EMD/SD amount remitted by the tenderer will be forfeited besides cancelling the Tender.

18. Issue of Purchase Order

After successful execution of the agreement and deposit of SD if applicable, Purchase Order will be released by the IA. The successful tenderer should complete the supply, erection and commissioning of machineries, equipment and its accessories at the Livelihood Business Incubator Centre of J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI, Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu State, within 15 days from the date of receipt of Purchase Order. The work is to be carried out on a LSTK basis covering all fixtures tools, pipelines, water supply, equipment, electrical control panel, power boards, cables, switches etc. including minor civil works for installation and any other seen/unseen items that may be conditional requirement for installation & commissioning of the machineries.

19. Schedule of Supply

- a) The specification of machineries, equipment and its accessories should be as per Annexure-I of the respective package. The supply, erection & commissioning and performance test of machineries, equipment and its accessories for the respective packages shall be completed within 15 days from the date of issue of purchase order. Delay beyond this period may attract penalty (0.5% PER WEEK) Delays beyond that period will be viewed as violation of the contract terms and will be dealt accordingly. The machineries, equipment and its accessories should be delivered and installed at J.K.K.MUNIRAJAH COLLEGE OF AGRICULTURAL SCIENCE LBI, Thookkanaickenpalayam Post, Gobichettipalayam Taluk, Erode District, Tamil Nadu State.
- a) The supplier shall include manufacturer recommended list of spares (MRLS) & cost thereof for two years successful running of the machine in their quotation. There shall be no additional financial obligation on part of the implementing agency for any MRLS consumed during the 2

years. The IA in consultation with the TA will ascertain if the supplier has provisioned adequate number and quality of spares as part of the delivery.

- b) If the contract is not completed within the stipulated time or extended time, Tender Committee will hold full authority to cancel the tender or take any such action that will be deemed fit to the occasion at the risk and cost of the successful tenderer. Such cancellation will entail forfeiture of EMD and Security Deposit.
- c) In the event of non- performance of the contractual provisions or failure to effect the supply, erection & commissioning and performance test within the stipulated time or during the extended period and if it is found that the supplier, has not fulfilled the contractual obligation with IA in any manner during the currency of the contract or also found on later date, Tender Committee reserves the right to disqualify such supplier to participate in future tenders or black list the firm up to a maximum period of 3 years.
- d) Every step will be taken by the IA to make infrastructure ready at the scheduled time of dispatch of Machinery, equipment and its accessories. If there is any delay due to any reason on the part of the IA, release of payment will be considered based on delivery schedule given in Purchase Order.

20. Performance Test

- a) The successful tenderer shall demonstrate the performance of the machineries, equipment, and its accessories in complete conformity with the relevant technical specifications and performance parameters as specified in the Purchase Order.
- b) This demonstration should be done as stipulated by the IA in the presence of the TA.
- c) The performance tests should be completed within 30 days from the date of delivery of machineries, equipment and all accessories. However, the period of supply, erection, commissioning, and performance test should not exceed the period stipulated in the purchase order.
- d) The supplier shall support to the best of their ability - support and be responsible for the statutory licenses and clearances required by the cluster farmers to begin commercial production from the unit. Bidders are encouraged to visit the location before bidding to ascertain current road conditions, location conditions and considerations.

21. Performance Guarantee

- a) The machineries, equipment and its accessories are to be guaranteed for a period of 12 months from the date of completion of performance test against manufacturing defect, bad workmanship or poor performance.
- b) During performance guarantee period of 12 months the successful tenderer should attend any call from IA immediately, in case of any problems, related to operation or malfunctioning of the machinery, equipment & accessories, without any delay for regular operation of the machinery. The above service should be done at Free of cost.
- c) After completion of one year performance guarantee period successfully, the SD security deposit furnished by the tenderer or SD retained by the IA, will be returned to tenderer, after recovery of dues if any.

22. Payment terms

100% payment will be done after 100% delivery of machineries at our site.

23. Termination of Contract

IA in consultation with Working Committee reserves the right to terminate the contract at any time during the validity period on account of non-fulfilment of contract or for any of the reasons.

24. General Conditions

- a) Conditional tender in any form will not be accepted.
- b) Any notice regarding any matters, to the contractor shall deemed to be sufficiently served, if given in writing to his usual or last known place of business.
- c) Tender committee reserves the right to relax or waive or amend any of the tender conditions.
- d) The successful tenderer shall not outsource/off load either full or part of the work to any other agency / individual.
- e) If the performance of the tenderer is not as per the schedule, then tender committee reserves the right to cancel / reallocate full or part of the contract, at any stage of the contract execution.
- f) All items shall be verified at site for quality and quantity by designated representative(s) of the IA in consultation with the TA at the Common Facility Centre upon delivery.

25. Arbitration

- a) In case of any dispute in the tender, including interpretation, if any, on the clauses of the tender or the agreement to be executed, the matter shall be referred by IA / Tenderer to an Arbitrator to be appointed by the Parties hereto by mutual agreement. If no such Arbitrator could be

appointed by mutual consent, the matter may then be referred to the (TA) JKK Munirajah College of Agricultural Science LBI, Thookkanaickenpalayam, for nominating an Arbitrator, the Arbitration proceedings being governed by the Arbitration and Conciliation (Amendment) Act 2015.

- b) The venue of the Arbitration shall be at the (TA) JKK Munirajah College of Agricultural Science LBI, Thookkanaickenpalayam. The decision of the Arbitrator shall be final and binding on both the parties to the Arbitration.
- c) The Arbitrator may with the mutual consent of the parties, extend the time for making the award. The award to be passed by the Arbitrator is enforceable in the court at Tamil Nadu.

26. Jurisdiction of the Court

Any dispute arising out of non-fulfilment of any of the terms and conditions of this Agreement or any other dispute arising out of the arbitration award will be subject to the jurisdiction of the Courts in the City of Tamil Nadu only.
